

ORDINANCE 2005-08-01

AN ORDINANCE REGULATING TRAFFIC SPEEDS ON VARIOUS TOWN HIGHWAYS.

WHEREAS, the Town Board has determined that it is necessary in the interest of public safety to review various traffic regulations in the Town; and

WHEREAS, in September of 2004, the Dane County Highway Department, at the request of the Town Board, monitored 5 different segments of three roads and determined that the average speeds were over 55 mph for almost every hour of every day, and the peak speeds were 75 mph or greater on each day monitored; and

WHEREAS, the members of the Town Board have also made individual observations and investigations as to the speeds of actual travel on Town highways and;

WHEREAS, the Town Board has determined that vehicles traveling on Town highways routinely travel at speeds in excess of the current speed limits and in excess of the speeds which are reasonable and prudent considering the design and condition of the highways, adjacent land uses and other factors;

NOW, THEREFORE, the Town Board of Rutland, Wisconsin, does ordain as follows:

Section 1. The Town Road Patrolman shall cause official speed limit signs to be installed at appropriate locations to regulate the speed on the following highway segments within the Town to the speed limit indicated:

Section 2. Upon installation of the sign authorized in Section 1, no person shall operate a motor vehicle in excess of the speed limit provided therein.

Section 5. Any person who shall be convicted of violating the provisions of this Ordinance shall be subject to forfeitures in the amounts provided in §§346.60(2), *Wis. Stats.*

Section 6. This ordinance shall be effective upon enactment and publication as provided by law.
