

ORDINANCE 2005-08-02

AN ORDINANCE REGULATING TRAFFIC AT VARIOUS INTERSECTIONS OF TOWN HIGHWAYS.

WHEREAS, the Town Board has determined that it is necessary in the interest of public safety to review various traffic regulations in the Town; and

WHEREAS, the Town Board has determined that it is necessary to require vehicles to come to a complete stop before entering certain intersections in order to improve the safety of those intersections;

NOW, THEREFORE, the Town Board of Rutland, Wisconsin, does ordain as follows:

Section 1. The Town Road Patrolman shall cause official "stop" signs to be installed at the following locations within the Town:

Section 2. Upon installation of the sign authorized in Section 1, all vehicles shall stop before entering said intersections as required by §346.46, *Wis. Stats.*

Section 3. The Town Road Patrolman shall cause official "yield" signs to be installed at the following locations within the Town:

Bass Lake Road	Eastbound	Bass Lake Court and Northbound Bass Lake Road
Oak Opening Drive	Northbound	Deer Point Drive
Oak Opening Drive	Southbound	Deer Point Drive
Starr School Road	Northbound	Eastbound and Westbound Starr School Road

Section 4. Upon installation of the sign authorized in Section 3, all vehicles approaching the "yield" sign shall yield the right-of-way to other vehicles which have entered the intersection from an intersecting highway or which are approaching so closely on the intersecting highway as to constitute a hazard of collision and, if necessary, shall reduce speed or stop in order to so yield as required by §346.18(6), *Wis. Stats.*

Section 5. Any person who shall be convicted of violating the provisions of this Ordinance shall be subject to forfeitures in the amounts provided in §§346.22 and 346.49, *Wis. Stats.*

Section 6. This ordinance shall be effective upon enactment and publication as provided by law.
