Schedule of Fees Required by Town Ordinances

ORDINANCE 06-12-01

AN ORDINANCE REPEALING ORDINANCE 05-11-01 AND ESTABLISHING A REVISED SCHEDULE OF FEES REQUIRED BY TOWN ORDINANCES.

WHEREAS, the Town Ordinances provide for the establishment of certain fees by the Town Board for the issuance of licenses and for other services provided by the Town; and

WHEREAS, the Town Board has reviewed the various fees charged for certain services, and has evaluated the cost to the Town of providing those services; and

WHEREAS, the Town Board has determined that certain fees previously included as part of the dog control ordinance should now be included in the Schedule of Fees required by the revised Dog Control Ordinance

NOW, THEREFORE, the Town Board of Rutland, Wisconsin, does ordain as follows:

- Section 1. Town of Rutland Fee Schedule Ordinance 05-11-01 is hereby repealed, and the fee schedule attached hereto as Addendum A is hereby adopted and shall apply to the activities listed on and after the effective date of this ordinance. Neither the repeal of Ordinance 05-11-01, nor any provision of this Ordinance, shall affect the validity of any fee imposed or collected prior to the effective date hereof.
- **Section 2.** The provisions of this ordinance are intended to be severable. If any provision of this ordinance, including any provision on Addendum A, shall be declared invalid or unenforceable, such determination shall not affect the remaining provisions hereof.
- **Section 3.** This ordinance shall take effect the day after posting or publication as provided by law.
